Rules for Celebrating Safely

Rides will be provided from a bar or restaurant to an individual’s residence—not to other drinking locations. Due to the high number of requests on Cinco de Mayo, rides can’t be guaranteed for everyone who calls; however, every attempt will be made to accommodate all requests. Patrons are encouraged to tip their cab drivers.
