Rides are for adults who have been drinking or who need a safe way home. Rides will be provided from a bar or restaurant to an individual's residence—not to other drinking locations. Due to the high number of requests on Halloween, rides can't be guaranteed for everyone who calls; however, every attempt will be made to accommodate all requests. Patrons need to remove masks or other facial coverings, and drivers have the right to use their discretion when accepting fares. Patrons are reminded to tip their drivers accordingly.
